



# RESOURCES FOR ADULTS ENGAGING WITH CHILDREN: HOW THE CLIMATE CRISIS AFFECTS VIOLENCE AGAINST CHILDREN

For the office of the Special Representative of the Secretary-General on Violence Against Children (SRSG-VAC), children's participation is a key component of her mandate and a cross-cutting priority\*. Throughout different actions the SRSG-VAC promotes a culture of meaningful and representative child participation, where children, as key stakeholders in all matters concerning their safety and wellbeing, are also actors and agents of change in the development of integral protection systems. A key aspect of a culture of meaningful participation is bridging the gap between children who are taking actions and decision makers, by facilitating access to information that can be used by children to input their own actions and initiatives, and that has been adapted to fit children's needs.

The following resource has been developed to support those who engage with children, to help educate on the relationship between the climate crisis and violence against children. It combines educational materials that have been developed by the office of the SRSG-VAC, with the goal of making this information available to children in an accessible and child-friendly format.

## WHAT DOES CHILD-FRIENDLY MEAN?

Children have the right to seek and access information, especially that 'aimed at the promotion of their social, spiritual and moral well-being and physical and mental health'\*\*. For this right to be implemented it isn't enough to make the information available: It needs to be packaged in an accessible format for children.

Child-friendly content is content that has been 'made' or developed for children, keeping in mind their age, their evolving capacities, their right to be protected from all forms of violence, their language, and accessibility and limitations amongst other aspects.

The following documents contains child friendly materials, together with additional resources that should support practitioners when engaging with children on how the climate crisis affects violence against children.

### HOW THE CLIMATE CRISIS AFFECTS VAC: EXPLANATORY VIDEOS

Because the connection between the climate crisis and violence against children is not a natural one to make, we put together two short videos for children. One explains how climate change triggers

displacement, and the other one makes the connection between the climate crisis, dropping out of school, and child marriage.
